Dear visitor,

You have come to us today to carry out maintenance, servicing or other activities in the ITVP **clean rooms**, for which special requirements apply. Please note the following:

- Only enter cleanrooms through the personnel lock (not through the material lock)!
- Wearing socks/stockings and leg coverings (long pants, tights...) is mandatory.
- About the order of dressing:
 - \Rightarrow Beard wearers must put on a beard bandage.
 - \Rightarrow Put on a hood (hair must be completely covered).
 - ⇒ Put on overshoes on the lock bench. If necessary, put the black EX-protective band into the sock/shoe; then do not touch the unclean side of the lock (the side facing the exit)!
 - \Rightarrow Put on a protective coat and close completely.
- <u>Hygiene measures to be observed</u>:
 - ⇒ Wash hands, dry carefully and only then disinfect! (Soap and disinfectant are available in dispensers at the sink.)
 - ⇒ Allow disinfectant to work for at least 30 seconds!
 - ⇒ Do not enter cleanrooms with severe colds or infectious diseases!
 - ⇒ Cover any skin wounds tightly and wear gloves (disposable gloves are available). If in doubt, please ask the supervisor.
 - ⇒ No cosmetics (make-up, eye shadow, blusher, lipstick, mascara, etc.) and no painted fingernails may be worn!
 - ⇒ Wearing jewelry and wristwatches is also not permitted.
 - \Rightarrow It is not permitted to drink, eat or smoke in the cleanroom.
 - ⇒ When leaving the cleanroom, first take off your protective coat.
 - Then change to the unclean side via the lock bench and use the waste garbage can there to remove the hood, beard- or face mask and overshoes in it.
- Clean objects/machines in the material lock before bringing them into the cleanrooms.
- Do not bring cardboard boxes into the cleanrooms! Use the plastic boxes out of/in the material lock!
- Please observe the designated escape routes at the location of your activities.
- Hearing protection (available on site) must be worn during noisy activities.
- If it is necessary to intervene in the production process as part of your activities (e.g. switching off the air conditioning, opening the ceiling paneling, switching off electricity or water), the supervisor must be informed in advance.
